- Review of returns iro 6 indicators from 6 LAs carried out by Performance Indicators Sub-Group from 22 to 29 July
- Data querying and verification by NOAC and LGMA continued into October 2016
- 2015 Report published on 7 November 2016
- [2014 Report published on 16 December 2015]

2015 Report - Issues

- Still some clarification issues re the Guidelines
- A couple of indicators didn't work as intended
- Some difficulties with the new LGReturns system, especially where changes needed to be made to the data Tables
- Some issues identified at Validation stage, e.g. housing stock figures
- Fewer queries than for 2014 report

2016 Report Timelines

- Request for data issued 26 January 2017
- Earlier data return deadline of 27 April 2017 must be met by all LAs
- Data checking and verification as well as sub-group review must be completed by early September
- Target report publication date: September 2017

Guidelines amended re:

- Housing H1
 - Social housing provided by AHBs should be included
 - Exclude LA dwellings that are unoccupied for the reason that their demolition is an integral part of a planned regeneration, refurbishment or reconstruction scheme approved in principle by D/HPCLG (also exclude from H2)
 - Indicate No. of single rural dwellings that are planned for demolition or sale due to dereliction (not for publication)
 - Re-wording of text re provision of net dwellings provided

Housing – H5

- RTB mid year registration figure
- Exclude repeat inspections
- Include all inspected dwellings in multi-unit buildings

Guidelines amended contd:

- Roads R1
 - Count once only kilometres surveyed more than once in year
- Planning
 - Only on-site inspections to be counted at P1
 - Cases resolved by agreement subsequent to a warning letter are to be included with enforcement proceedings cases at P3

Community – Y2

 Separately identify first registrations in 2016 and no. opting to join Social Inclusion College whenever registered

Corporate – C4

- Include cost of network links and other communications systems (Job Code ZCA) and traffic management system costs
- Exclude SCADA associated costs

2016 Guidelines - Clarification

- NWCPO will continue to provide the brown bin data
- Per capita revenue expenditure in 2016 will be derived from the 2016 Census figure for the LA area
- In compiling the total working days lost to sickness absence, exclude any illness leave taken by non-D/HPCLG staff for consistency with the WTE
